3-Month rental with buyout option. We require the Lessee to pay a three-month rental payment, inspection fee, and deposit in full before taking possession of each rental unit. After the initial rental period, Lessee may purchase the unit for the buyout option amount shown above. The inspection fee and deposit have already been subtracted from the buyout option price. If the Lessee decides to extend the rental period beyond the initial rental period, monthly payments as shown above are due by the 1st of every month. Diversified requires electronic payment system information (ACH) or a credit card on file for monthly payments. **A 4% finance charge will be added to the total bill when payment is by credit card.**

TERMINATION OF AGREEMENT. Should the Lessee defer any payment more than ten (10) days, or become bankrupt, or a receiver or assignee be appointed for Lessee’s business, the Lessor may, after thirty days’ notice, terminate this Agreement, take possession of the equipment without becoming liable for trespass or damage on any account whatsoever and recover all rental payments due and all expenses incurred in returning the equipment.

- The Lessee must update Lessor on the jobsite and nightly storage locations of the rental unit within 7 days of changing location.
- The Lessee is responsible for all shipping costs including returning the unit. All shipping is FOB origin.
- Rental period begins when the unit has been received via shipping or pick-up by the Lessee.
- Lessee has 7 business days to return the unit after the rental period has ended.
